The Mount Vernon Place Conservancy's mission is to be the full-time single management entity responsible for the historic restoration, oversight and protection of the Washington Monument, along with maintenance and management of Mount Vernon Place.

The primary focus of the Conservancy was developing restoration plans and soliciting approvals from appropriate governmental bodies designated for the Washington Monument located in Mount Vernon Place, National Historic Landmark District located in Baltimore, MD. The Conservancy hired a restoration firm, a project manager and a general contracting firm to manage the restoration process.

MVPC still has the responsibility of maintaining the four square parks around the monument. We still have a contract with the professional landscapers to maintain the grass, urns and hanging baskets

The Conservancy sponsored year round programming in and around the squares, that was mostly free and open to the public. It included music, dance and theatre performances, movies, educational walking tours and children's programming as well as Halloween and Easter Egg Hunt community events. The Conservancy developed several outreach/educational tools and hosted several information sessions followed by Q & A for stakeholders and the community as well.
