1 Briefly describe the organization's mission: The Mount Vernon Conservancy Inc's mission is to be the full-time single management entity responsible for the historic restoration, oversight and protection of the Washington Monument, along with maintenance and management of Mount Vernon Place.

The primary focus of the Conservancy was the restoration of the Washington Monument located in the Mount Vernon Place National Landmark District located in Baltimore, MD. Henry H. Lewis Contractors (restoration firm) installed scaffolding and restoration of the tower which was completed in 2015.

4b (Code:) (Expenses \$ 135,590. including grants of \$ 0.) (Revenue \$ 0.) The Conservancy has the responsibility of maintaining the four square parks surrounding the Washington Monument. We have a contract with professional landscapers to maintain the grass, urns, fountains and hanging baskets.

4c (Code:) (Expenses \$ 216,785. including grants of \$ 0.) (Revenue \$ 0.) The single largest event for the Conservancy this year was the Monumental Bicentennial which was a one day celebration on July 4, 2015, featuring the official reopening of the restored Washington Monument. The event included a naturalization ceremony and an official rededication and ribbon cutting ceremony. The event included an old-fashioned county fair with entertainment, children's activities, baking contests and food and beverages.
